

## **KAGR “Future of Live Events” Report Terms of Use**

1. KAGR LLC (“KAGR”) is making available its Future of Live Events Report (the “Report”) to people and companies (“User(s)”) free of charge, and strictly subject to these terms and conditions (these “Terms”).
2. The Report is being provided to User for the purposes of evaluation and for internal business purposes only (“The Purpose”). User irrevocably releases and waives on behalf of User and any affiliated entities or persons, any claims (whether in tort or contract) or losses whatsoever suffered by the User arising out of or in connection with User’s use of the Report. User may not use the Report for any commercial purpose without KAGR’s express written consent.
3. THE REPORT IS PROVIDED “AS IS” AND KAGR MAKES NO WARRANTIES WITH RESPECT TO ANY INFORMATION OR DATA IN THE REPORT INCLUDING THE ACCURACY OR COMPLETENESS THEREOF, OR ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
4. Users shall indemnify, defend and hold KAGR harmless against all and any actions, claims, demands, damages, losses, costs, and expenses brought or made against, or suffered or incurred by KAGR arising out of the User’s use of the Report, or any information contained therein, in violation of these Terms.
5. Users shall not, and shall not permit a third party to: (i) copy, download, provide screen prints, modify, transfer or assign the Report, or any copy, adaptation, transcription or merged portion thereof, (ii) reverse engineer, de-compile, reverse-compile, translate, disassemble or reverse assemble the Report or any portion of the Report, (iii) use the Report for any purpose other than the Purpose, or (iv) sell, lease, assign, sublicense or otherwise transfer the Report in whole or in part, to any third party, including, without limitation, any parent, subsidiary or other affiliated entity.

The Report and all copies thereof (in any form) shall be and remain the sole property of KAGR and the User does not acquire by implication or otherwise any right in, or title to or license in respect of the Report. All inventions, improvements, modifications, or developments related to the Report that KAGR and/or User conceives or makes during or subsequent to User agreeing to these Terms, including those inventions, improvements, modifications and developments that may be based partly or wholly on User’s feedback, suggestions or recommended improvements to the Report pursuant to these Terms, will be the exclusive property of KAGR. EXCEPT FOR A BREACH BY USER OF THESE TERMS, NEITHER PARTY SHALL BE LIABLE FOR ANY CLAIMS FOR ANY DAMAGES WHATSOEVER INCLUDING PROPERTY DAMAGE, PERSONAL INJURY, LOSS OF PROFITS, INTERRUPTION OF BUSINESS, OR FOR ANY OTHER INDIRECT, SPECIAL, CONSEQUENTIAL OR INCIDENTAL DAMAGES ARISING OUT OF OR RELATING TO THESE TERMS, HOWEVER CAUSED, WHETHER FOR BREACH OF WARRANTY, CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE.
8. These Terms constitute the entire agreement between the parties relating to the Report. These Terms may not be changed except by a written document signed by each party. No terms and conditions will be considered waived and no breach excused by either party unless made in writing by the other party. No consent, waiver, or excuse by either party, express or implied, will constitute a subsequent consent, waiver or excuse. These Terms shall be binding upon User's heirs, successors in interest and assigns. This terms and conditions shall be governed by the laws of the Commonwealth of Massachusetts without reference to conflict of laws principles. By agreeing to these Terms, each party consents to the jurisdiction of the courts located in Massachusetts for resolution of any disputes arising in connection with the Report.
9. Those sections that by their nature are intended to survive, such as indemnification and ownership rights in the Report shall survive the termination or expiration of these Terms for any reason.
